Chair Zarr moved to approve June 14, 2018, and June 28, 2018 minutes. Seconded by Secretary Seamons. Motion carried 6-0.

2. Music on the Kuna Greenbelt Debrief, City Clerk Engels

City Clerk gave a breakdown of the expenses and revenues. Total expenses were \$4,565.95, our revenue was \$1,704.02, and our loss was \$2,861.93. Next year the commission should not have as many expenses and more of a profit should be made.

Chair Zarr stated that next time the vendor placement should be different. The food line was running into the alcohol line. Chair Zarr asked if we could start getting input from the food vendors by submitting a quick survey. Chair Zarr stated we should require weights on tents.

Commissioner Soldano informed the Commission that a better job of marking and posting signs of entrances and exits. He also suggested that we could have used another food vendor for the amount of people that showed up. Commissioner Soldano suggested we have a BBQ food vendor next time.

Commissioner Fisher shared that the quality of bands was outstanding and the sound was enjoyed by so many families of all ages. Commissioner Fisher also suggested having lights on the stage.

City Clerk Engels stated that overall the event went well other than one smoking incident, a group showing up with cuts and having to explain why they were not allowed unless they

removed their cuts, one incident of alcohol in the cooler which they happily returned to their car, and someone riding a four-wheeler which they left the premises.

3. Kuna Community Art Survey, Deputy Clerk Giddings

4. Potential Fall Concert, City Clerk Engels
