

**NOTICE OF PUBLIC HEARING  
PURSUANT TO IDAHO CODE § 67-8206(3)  
BY: CITY COUNCIL OF THE CITY OF KUNA**

**NOTICE IS HEREBY GIVEN:** That the City Council of the City of Kuna will conduct a public hearing.

**PURPOSE OF THE HEARING:** To receive comments regarding the City Council's intent to consider adoption of the following Capital Improvements Plan – Final January 2018-Amended June 2019 (“Amended Capital Improvements Plan”):

- Adoption of the Amended Capital Improvements Plan for the purpose of entering into an intergovernmental agreement with the *Kuna Rural Fire District* for the collection and expenditure of development impact fees for the Fire District's systems improvements as identified in the Amended Capital Improvements Plan.

**MATERIALS AVAILABLE FOR INSPECTION:** The City has made available to the public, upon request, the following: proposed land use assumptions, and a copy of the proposed Kuna Rural Fire District Impact Fee Study and Amended Capital Improvements Plan. Any member of the public, affected by the proposed Kuna Rural Fire District Impact Fee Study and the Amended Capital Improvements Plan, has the right to appear at the public hearing and present evidence regarding the proposed Kuna Rural Fire District Impact Fee Study and Amended Capital Improvements Plan. The City will send notice of this noticed intent to hold a public hearing by mail to any person who has requested, in writing, notification of the hearing date at least fifteen (15) days prior to the hearing date.

**PUBLIC OR WRITTEN TESTIMONY:** The public is invited to provide written or oral testimony for Council's consideration. Written testimony (letters) must be submitted to the Kuna City Clerk by **Thursday, August 29, 2019** at 5:00 p.m. to be included in the Council packets for review. Written testimony and documents may be dropped off at City Hall or mailed to P.O. Box 13, Kuna, ID 83634.

All persons wishing to testify must state their name and residential address. No person shall speak until recognized by the Mayor. A three (3) minute time limit will be placed on all testimonies.

**DATE, TIME AND LOCATION OF PUBLIC HEARING:** The public hearing will be conducted at 6:00 p.m. on the 3<sup>rd</sup> day of September, 2019 at Kuna City Hall, 751 W. 4<sup>th</sup> Street, Kuna, Idaho or as soon thereafter as this hearing is convened by the City Council.
