

**NOTICE AND PUBLISHED SUMMARY
CITY OF KUNA ORDINANCE NO. 2019-11**

CITY OF KUNA POLICE DEPARTMENT DEVELOPMENT IMPACT FEES

[PURSUANT TO I.C. § 50-901(A)]

Ordinance No. 2019-11 was considered by the City Council of the City of Kuna, Ada County, Idaho, and passed at its regularly scheduled Council Meeting on the 7th day of May, 2019. Said ordinance amended Title 12 of the Kuna City Code by the addition of a new Chapter 3, **providing for:**

- POLICE DEPARTMENT DEVELOPMENT IMPACT FEES;
- SHORT TITLE APPLICABILITY, FINDINGS AND PURPOSE;
- DEFINITIONS;
- IMPOSITION OF CITY OF KUNA POLICE DEPARTMENT IMPACT FEE;
- COLLECTION OF CITY OF KUNA POLICE DEPARTMENT IMPACT FEES;
- EXEMPTIONS;
- INDIVIDUAL ASSESSMENT PROCESS;
- DEVELOPER CREDITS AND REIMBURSEMENTS;
- METHODOLOGY FOR CALCULATION OF CITY OF KUNA POLICE DEPARTMENT IMPACT FEES;
- EXTRAORDINARY IMPACTS;
- FEE PAYER REFUNDS;
- ESTABLISHMENT OF A CITY OF KUNA POLICE DEPARTMENT IMPACT FEE CAPITAL TRUST FUND AND ACCOUNTS;
- USE, EXPENDITURE AND BUDGET PROCESS CITY OF KUNA POLICE DEPARTMENT IMPACT FEES;
- APPEALS, PROTEST AND MEDIATION;
- PERIODIC REVIEWS OF THE CAPITAL IMPROVEMENTS PLAN;
- AUDIT REPORT AS A PART OF THE CITY ANNUAL AUDIT;
- THE CITY OF KUNA POLICE DEPARTMENT DEVELOPMENT IMPACT FEE ADVISORY COMMITTEE;
- ENFORCEMENT AND COLLECTION;
- MISCELLANEOUS PROVISIONS;
- PUNISHMENT FOR VIOLATIONS OF THE ORDINANCE;
- CONSTRUCTION OF ORDINANCE INTENT; and
- PROVIDING AN EFFECTIVE DATE AND PUBLICATION.

Declaring validity and providing that this ordinance shall be in full force and effect as required by Idaho Code Section 67-8206 (6), shall be in full force and effect on the 30th day following its passage and approval and publication shall occur within one month of its passage and approval.

Interested persons may view the full text of this ordinance which is available for inspection at City Hall, City of Kuna, 751 West 4th Street, Kuna, Idaho during business hours, Monday through Friday, from 9 a.m. to noon and 1 p.m. to 5 p.m., excepting holidays.
