






Figure 6: Top Ten Congested Tier 1 Network Segments > 0.5 Miles (Peak period maximum, 2022)


### Distribution by User Type










Figure 1: Total New Residential Units Permitted by Year, 2001 – 2023



### All IFYP Projects

The Integrated Five-Year Work Program (IFYP) sets forth the strategies, projects and priorities which the Ada County Highway District (ACHD) will pursue over the next five years. The IFYP map shows construction projects by the year they are proposed to be built. ACHD updates the IFYP annually. A project year of FUT (Future) indicates that these projects are on the horizon to move into the IFYP in future updates.

*To view information regarding a specific project, click on the project in the map and a pop-up window will open and display some basic project information.*

If you only want to see a single type of project (road and intersection widening, bike and pedestrian projects, maintenance, etc.), just click on that project type tab. The map will then adjust to display only the
