## Preschool Scholarship Program Guidelines

- 1) All application information must be fully completed and submitted on time by the parent or guardian of the scholarship applicant in order for the application to be considered. This includes the interview process, application form, and proof of income.
- 2) Scholarship award will be awarded to one eligible child per year.
- 3) Scholarship applicants must be residents of the City of Kuna.
- 4) The child must be four (4) years old by September 1st.
- 5) The scholarship awarded to the student covers the cost of full tuition and all supplies needed. Scholarship does not cover child care services (before or after preschool). Child must not arrive before 8:30 AM and must be picked up at 3:30 PM (overtime charges will apply).
- 6) No person(s) shall receive any direct cash benefit from any scholarship award(s).
- 7) Acceptance of scholarship does not exempt the family or student from abiding by the policies and guidelines of Get Ready to Learn, Kuna! (GRtL,K!) and Kids Independent Day School (KIDS).
- 8) This scholarship award will go through from September 7, 2021 to June 2, 2022.
- 9) Part of the scholarship is mandatory participation on three parent trainings: October 19, January 25, and April 19.
- 10) As part of the scholarship project, two parental consents are requested: first, to compare preschool's Kindergarten Fall IRI scores with those who did not participate the GRtL,K!; second to use photos for GRtL,K! communication to the community.
- 11) The parent or guardian must notify GRtL,K! and KIDS immediately if they wish to withdraw.
- 12) Children need to attend at least 85% of their enrolled schedule per month. With the exceptions of illness, or other extenuating circumstances, missing more than 10 days per trimester or 20 days per school year will render the student ineligible for the scholarship. You will be dismissed from the program.
- 13) Transportation to and from KIDS is the responsibility of the parents or guardians.
- 14) All application information will be maintained by GRtL,K! in the strictest of confidentiality and will not be used for purposes other than application for the scholarship and providing required reports.
