



Beer and Wine Park Use Permit

\$11.00 per day

Kuna City Code (KCC) 7-3-16 BEER AND WINE PARK USE PERMIT: It shall be unlawful for any person, association, corporation entity or group, to sell, distribute, possess or consume any type of alcoholic beverage on the premises of any Kuna City Park and City Public Property, except as is specifically provided in this section.

Permit Conditions:

1. Limited to the following park locations: Bernie Fisher, The Farm, Arbor Ridge, Nicholson, Sadie Creek, Winchester, Greenbelt, and Butler;
2. Park area availability;
3. Individual possession is limited to beer and / or wine;
4. Limitation of seven and one-half (7.5) gallons of beer and/or wine or less;
5. Must be twenty-one (21) years of age to consume or possess beer and / or wine;
6. All State, County, and City laws in regard to alcoholic beverages shall be obeyed;
7. Beer and / or wine may only be sold or vended in any fashion, or be distributed as a basis to solicit donations, pursuant to the alcohol beverage catering permit provided by the Applicant and which alcoholic beverage catering permit must be posted at the Permit site;
8. Persons who are subject of the Permit shall not disturb the peace of any other user of the park;
9. Persons who are the subject of the Permit are also subject to park policies;
10. Violators of Permit conditions are subject to ejection from the park by a law enforcement officer or City Parks Department official;
11. In the event of a violation or violations, the Applicant and any person who is the subject of the Permit violation shall be ineligible for a one (1) year period subsequent to the date of the violation;
12. Applicants are responsible to leave the subject area of the Permit clean and without litter;
13. Applicants are responsible for the actions of any persons who are subject of the Permit and must remain present, be in possession of the Permit and shall produce the Permit upon request of law enforcement officer or City Park official at all times which are the subject of the Permit;
14. The City of Kuna assumes no liability for the negligence of any persons who are subject to the Permit; and
15. Permits are valid only during the date, time period and location listed on the Permit.
